UNDERTAKING by Parent or Guardian.

I, (full name in block capitals) KENNETH GRIFFITH HUGHES
of (address) 6, HAWTHORNE ROAD, HIGHER TRANMERE, the Parent/Guardian
of ALUN LESLIE HUGHES
who was born on the 2nd day of April, 1955
(hereinafter called "the Pupil") in consideration of the admission of the Pupil at the above-named
Secondary School HEREBY UNDERTAKE and agree with the Mayor, Aldermen and Burgesses of the
County Borough of Birkenhead being the Birkenhead Education Authority (hereinafter called "the
Authority") as follows, that is to say:—

- (a) The Pupil shall not without the consent of the Authority cease to attend the said School before the end of the secondary school year in which the Pupil shall attain the age of sixteen years, namely, 1st September in the said year.
- (b) The Pupils shall observe all the rules and directions of the Authority and the Headmaster or Headmistress as the case maybe of the said School and shall attend all such public examinations as ~~from~~ part of the school course in which the Pupil is working during the aforesaid period.
- (c) I as Parent or Guardian of the Pupil will secure the regular and punctual attendance of the Pupil at the said School and the exercise of due diligence in the private studies and homework of the Pupil during the whole of the aforesaid period.

For the consideration aforesaid and also in consideration of the expenses incurred by the Authority on the education of the Pupil at the said School I HEREBY AGREE with the said Authority that in the event of the Pupil being withdrawn from the said School in contravention of the terms of this undertaking except for illness or with the previous consent in writing of the said Authority which will not be unreasonably withheld, I will pay to the said Authority the sum of TEN POUNDS (£10 0s. 0d.) as liquidated damages and not as a penalty PROVIDED ALWAYS that nothing hereinbefore contained shall extend to prevent the said Authority from instituting such proceedings whether under the Education Acts, 1944—1962 or otherwise as they may deem appropriate against me in respect of any failure to observe any of the undertakings or the agreement hereinbefore contained.
